Poly Phone and Headset Rebate Program

Program Terms and Conditions

- Program Term—This rebate program ("Program") is valid from January 1-June 30, 2020 ("Program Period").
- Program Only Open to End User Customers—This Program is exclusively for end user customers ("Customer" or "Customers") in North America who purchase five or more new Polycom desktop or conference phones from an authorized Poly reseller during the Program Period. This Program does not apply to Polycom or Plantronics resellers, consultants or distributors. However, resellers can claim on behalf of a Customer as long as full customer details are provided. Individuals employed by government agencies or political parties, or who are elected or government officials, are not eligible to participate in this promotion.
- Purchasing, Lease Agreement or Service Contract from Authorized Poly Resellers—This Program applies only to the purchase of new Poly products eligible for this Program as set out at http://polyrebate.com ("Eligible Products") from an authorized Poly reseller. For Eligible Product acquired under a Lease Agreement or Service Contract, the Customer must purchase a twenty-four (24) month or longer, non-cancellable service contract or leasing agreement from authorized Poly reseller covering the Eligible Products.
- Rebate Phone Requirements—The Customer's displaced equipment as set out above ("Displaced Equipment") must be in current use and working condition, and cannot include desk or conference phone expansion units. The Customer's Displaced Equipment must be replaced with Eligible Products on a "one for one" basis.
- Minimum/Maximum Eligible Products—There is a minimum of five (5) Eligible Products per claim. You are encouraged to submit all phones on one claim. There is also a maximum of up to two hundred (200) phones that may qualify for rebates under this Program.

• Rebate Headset Requirements—The Customer may apply for rebates on eligible new Plantronics headsets as set out http://polyrebate.com ("Eligible Headsets") purchased on the same invoice, lease agreement or service contract with the Eligible Products submitted on the claim. Customer may receive a rebate for one (1) Eligible Headset per one (1) Eligible Product for rebate, subject to the maximum Eligible Product limit described above. Eligible Products must be purchased with Eligible Headsets in order to receive rebates on the Eligible Headsets; rebates will not be provided on standalone headset purchases.

Rebate Claims Process

- **1.** The Poly Phone and Headset Rebate Program Claim, with all required documentation (outlined below in section 2), must be submitted within either:
 - a. Ninety (90) days of purchase of the Eligible Products or
 - b. One hundred fifty (150) days from the date of the effective contract date for Customers who have purchased long-term telecommunications service contracts.

Note: If the completed documentation is not received within 90 days from date of purchase or within 150 days from date of signature on long term telecommunications services contracts, program participation will be declared invalid, and the Customer will not receive the rebate. Rebate checks made payable to the Customer will be sent within 6-8 weeks after claim is accepted as valid.

- 2. Rebate Documentation—Customers are required to provide the following documentation directly to Poly in order to receive the promotional rebate:
 - a. Completed Poly Phone Rebate Form including:
 - I. Signed Authentication;
 - II. List of the Eligible Products purchased, with model and serial numbers for each Eligible Product for which rebate is requested: and
 - III. List of the Displaced Equipment being replaced by the purchased Eligible Products (if Polycom legacy equipment provide serial numbers); and
 - IV. If Eligible Headsets are part of rebate claim, a list of the Eligible Headsets purchased, with model numbers for each Eligible Headset for which rebate is requested.
 - b. Proof of Purchase (one of the three options listed below):
 - **Option 1—**Invoice for Eligible Product and Eligible Headsets purchases from an authorized Poly reseller dated between January 1— June 30, 2020, OR
 - **Option 2**—Long-term Equipment Lease or Services contract AND first month's invoice for long-term equipment Lease or Telecommunications Services contract with authorized Poly reseller
 - **a.** Long-term Equipment Lease or Services contract for phones and headsets must be signed between January 1–June 30, 2020. First month's invoice must be dated no later than 150 days after contract date.
 - b. Contract must show quantities and descriptions of Polycom and Plantronics equipment being leased or put into use.
 - **c.** Lease Agreement or Service Contract customers must purchase a twenty-four (24) month or longer, non-cancellable service contract or leasing agreement from authorized Poly reseller covering the Eligible Products and Eligible Headsets.
- 3. All documentation must be completed via the online portal at http://polyrebate.com
- **4.** Poly will provide the Customer with an email confirmation when Poly receives the Customer's claim. Polycom is not responsible for lost or misdirected email, mail or faxes.
- **5.** Poly or Poly's Rebate Administrator has the right to contact the Customer at any time for verification purposes. Poly retains the right to decline if verification cannot be validated.
- **6.** This Program is valid in the United States and Canada and is void where prohibited or otherwise restricted by law. All programs are subject to US export laws and restrictions.

- 7. This Program may not be combined with any other promotional offer or discounts, and Poly reserves the right to modify or cancel this Program at any time.
